Agreements:

- 1) For your child(ren) to participate in the before or after school program the child(ren) must be enrolled in the before/after-care program. There is no charge for 21st Century time, but there is a tuition rate for the extended care program.
- 2) The Friday 21st Century program will operate from 8:00 a.m. to 1:00 p.m.
- 3) Transportation is provided on a limited basis. There will be fewer bus stops than normal. Prior to beginning the program you will be notified of your child's bus stop.
- 4) There are a limited number of spaces for the Friday program. Services will be offered on a first come first serve basis. You will be notified when your child is accepted.
- 5) The Friday 21st Century Program is considered an extension of our school programs. All rules, regulations, policies, and procedures will be applicable. Students will be held to the code of conduct approved for the 2018-2019 school year. Students who frequently violate student discipline guidelines, and/or disrupt the Friday 21st Century program may be removed.
- 6) Students who have frequent absences in the program (more than 1 a month), and there is a wait list will be removed from the program.
- 7) If a child is a parent pick up or drop off they must pick up and drop off at the designated times. Failure to do so may result in the child being removed from the program.
- 8) The program begins August 10th, 2018. There are certain days the program is not offered. The Fridays that 21st Century is not offered are October 19th, November 23rd, December 21st, December 28th, January 4th, and March 22nd.
- 9) On special occasions, we may show a family friendly, school appropriate movie.
- 10) Students are expected to be active participants in their selected classes and programs. Students who do not participate consistently may be removed from the program. The site coordinator will contact the parent/guardian prior to removal with any concerns.
- 11) If a student is currently suspended from school, they are ineligible to attend the 21st Century program until the suspension has ended.
- 12) Enrollment and acceptance in the Friday program is not a guarantee the child(ren) will be eligible for 21st Century during the school week.
